

# How to use the Florida Department of Health's Septic Scheduling Application

- 1) Select the type of inspection you wish to schedule. Either a Final Inspection or a Reinspection.
- 2) Select the day for the inspection.
- 3) Select the available time. (Please note that the time slot selected is not a guarantee that our inspectors will be out at that time. Inspectors will arrive at the location any time during the normal business hours of 7:30 a.m. to 2:30 p.m. on the scheduled day.)
